I bring the experience of know the healthcare industry with an emphasis on public outreach, education and public relations, meaning I will not only advocate for positive policy changes for the district, and it's patients, but will also focus on making sure the community knows about them.

I am currently a member of the Big Bear Trails Foundation and also hold a membership with the Society of Healthcare Strategy and Market Development (Associated with the American Hospital Association). I am a member of the Big Bear Cycling Association and am a local HAM radio operator. I was also a long-time member and award-winner in the Society of Professional Journalist.

2. Why do you wish to serve on the Board and what do you hope to accomplish? I've always believed in donating my time for the public good and believe I am in a unique position to do so with my background in public information and healthcare administration. I want to reintroduce an emphasis on listening to the public and keeping them informed of business at the hospital, similar to Ray Hino's 2013 town hall meetings, but creating other ways of reaching the community as well.

I would also like to create affiliations with partners that will better fulfill their obligation than Loma Linda did. This would include exploration with organizations such as Riverside Community Hospital to form a more mutually beneficial partnership. In addition, I would like to work with the board to free up any resources available to creative new ancillary services with a positive return on investment based on reimbursement.

3. What skills, abilities, and experience would you bring to the Board to assist in carrying out its responsibilities?

From journalism to public information, my career as a professional communicator is well documented and diverse enough to provide creative thinking and unique perspectives. Coupled with my experience in Healthcare, I think I can bring value to a board already making positive strides for the district. I am an award winning journalist, have written \$5 million in successful grants, am experienced in social media, public outreach and education and public relations.

Access is an issue facing many health care institutions, but more so in a rural districts such as Bear Valley's. I would focus on more access to specialists through increased recruitment and explore other opportunities such as telemedicine.

Explore partnerships and contracts with medical groups to increase patient volumes being careful not to effect current reimbursement rates.

See what can be done to increase physician and specialist recruitment so that Bear Valley Community Hospital is a destination for services that patient seek.

Explore other ancillary services such as stress tests and echocardiograms.

Although there are many challenges to the Health Care industry (i.e. cost pressures, a changing regulatory environment, implementing new technology, the emphasis on preventative care, large health-system mergers, system complexity, etc), I think the main challenges are around the necessity to evolve and adapt in a technology driven and consumer focused world. Some main challenges in this "technology driven, consumer focused" area that I see are:

- I. Data related Challenges: Data collection practices, medical data fragmentation, data privacy, data analysis for better diagnosis, etc. There is more information available to us to compare and select a new car than we have to choose where to go for lifesaving health care.
- 2. Customer-Facing technology. People are more tech savvy now and expect/ demand the ease and simplicity they are used to with sites like Amazon.
- 3. Leveraging new technology available in Healthcare industry for more effective and efficient care.
- 4. Human factors: Such as problems with Physician inaccessibility, I think technology can help in this area as in other industries.

These challenges are exasperated in small regional health care districts like ours in Big Bear where necessary financial resources may not be as accessible as in larger districts.
